FEES FOR STAY/TRANSPORT SERVICE

The prices for hunting trips are governed by the current price list for the exact hunting area. In principle, the price for accommodation is fixed, but if the hotel or hunting lodge has a higher standard of accommodation (4 stars and more) we need to add extra charge (this information will be included in the price offer). In most places the check-in starts at 12:00 p.m. and ends at 10:00 a.m. (Travel agent will inform about check-in and check-out hours). All clients needs to check-out at the front desk before the next day stay begins. If a hunter check-out after this hour, will be charged for another day of stay. All payments need to be pay to travel agent.

A person accompanying a hunter to a hunting destination is considered an accompanying person. As a rule, it draws only services related to accommodation and catering. The accompanying person is not entitled to use services related to the exercise of hunting rights in the hunting area.

The organization of a common hunt (driven hunt or any kind of common hunt) includes comprehensive services related to the reservation of the selected date, the completion of the necessary formalities, by ordering accommodation and securing a support team of hunters, dog handlers and other support staff.

GENERAL INFORMATION

1. All correspondence concerning services provided by **Arms & Ammo Solutions**, **s. r. o.**, (request for our offer or price list to be sent, booking hunting trips, ordering additional services, remarks and complaints relating to clients stay) shall be sent to the **Arms & Ammo Solutions**, **s. r. o.**, address:

- 2. All orders and bookings shall be made on the "Hunting Order Form", which each time shall be enclosed with the offer, which **Arms & Ammo Solutions, s. r. o.,** sends to the clients. The Form should be filled in carefully and legibly and signed by the contracting party. Bookings made in any other fashion shall not be realized.
- 3. Bookings may be made by:
 - ✓ any individual client,
 - ✓ an individual hunter who is the hunting team leader and on behalf of the whole team.

In the upper case the team authorizes its leader to conclude a contract with **Arms & Ammo Solutions**, s. r. o., on behalf of all people participating in the hunt being booked.

OFFER AND CONTRACT

- 1. The offer which Arms & Ammo Solutions, s. r. o., sends the client shall include the following information:
 - ✓ a general place and area of hunting,
 - ✓ the offered number of game earmarked for shooting, whereas Arms & Ammo Solutions, s. r. o., hereby warns that, in the case of hunts according to the price list, the specified numbers of game do not constitute the Arms & Ammo Solutions, s. r. o., guarantee as to the hunt's results,
 - ✓ in the case of hunts at a flat-rate cost, the guaranteed number of game earmarked for shooting,
 - ✓ accommodation information and photos,
 - ✓ a suggested date of hunt and no. of hunters,
 - ✓ the cost of stay during the hunt,
 - ✓ in the case of hunts according to the price list, the manner of paying for the game shot,
- 2. The contract shall be concluded each time after the client has signed a filled-in the "Hunting Order Form" and has sent it to **Arms** & **Ammo Solutions**, s. r. o., and the client is required to make an advance payment.
- 3. After the client has sent the filled-in "Hunting Order Form" and has made the prescribed advance payment, HE/SHE shall receive a written confirmation of the hunting trip's acceptance from **Arms & Ammo Solutions**, s. r. o.
- 4. After **Arms & Ammo Solutions**, **s. r. o.**, has received the advance payment, it shall be obliged to issue and send to the client a VOUCHER, which shall be made out using the data provided by the client on the "Hunting Order Form". This VOUCHER, along with the client's ID or passport and a European Gun Permit, shall constitute the grounds for a permit to bring hunting arms into determined EU country. However, the above-mentioned refers only to EU citizens. Hunters from outside the EU should also visit their local Consulate of the determined EU country bringing the Voucher along and request a permit to bring arms into determined EU country. Each hunter shall be obliged to carry these documents at all times during their stay in determined EU country and present them on request from proper authorities.
- 5. Any amendments made by the client after the booking could been accepted only with the consent of **Arms & Ammo Solutions**, **s. r. o.**, and must be made in writing.
- 6. Arms & Ammo Solutions, s. r. o., reserves itself the right to amend the contract due to reasons beyond Arms & Ammo Solutions, s. r. o., control or the number of participants differs from the minimum required by Arms & Ammo Solutions, s. r. o., and specified in the offer.
- 7. Arms & Ammo Solutions, s. r. o., reserves itself the right to cancel the hunting trip up to 14 days prior to its commencement, or any time due to reasons beyond the organizer's control.



PAYMENT CONDITIONS

- 1. The prices of Arms & Ammo Solutions, s. r. o., services are prices including the VAT and presented in Euro (EUR).
- 2. At concluding the contract, the client shall be obliged to make an advance payment prescribed by Arms & Ammo Solutions, s. r. o.
- 3. In case of receiving group from airport transfer fee from/to your accommodation place will be divided for each hunter. We choose the appropriate bus to the number of hunters, so that all came by one bus. Price per km is include in "Pricelist" document.
- 4. The remaining cost of the stay during the hunting trip (accommodation and food, preparation of the hunting ground, organization of the hunt, a beater or a beat with hounds, preparation and evaluation of trophies, liability insurance, an interpreter, administrative fees, the voucher) should necessarily be paid prior to the hunt, but not later than 30 days before the planned commencement of the hunt, unless *Arms & Ammo Solutions*, *s. r. o.*, grants another deadline for the payment of the full amount due. Resignation from the hunting need to be send on "Resignation from the Hunting Trip" document.
- 5. As for the conditions and form of payment for the game shot and trophies, these shall be estimated each time and sent to the client in the offer.
- 6. **Arms & Ammo Solutions, s. r. o.,** reserves itself the right to demand advance payment for game earmarked for shooting before the commencement of the hunt.
- 7. Any and all advance payment for game earmarked for shooting received prior to the hunt shall be settled following the hunt protocol. In case the advance payment exceeds the price of the game shot due to *Arms & Ammo Solutions, s. r. o.*, the complete excessive amount shall be paid back to the client.
- 8. Any and all settlements between *Arms & Ammo Solutions, s. r. o.*, and its clients shall be made in EURO. Payments can be made by money transfer into the following account:

9. **Arms & Ammo Solutions, s. r. o.,** reserves itself the right to change the prices of the hunting trip in cases of emergency, such as an increase in transport costs or official fees or taxes. In the period beginning on the twentieth day prior to the hunt, the price stipulated in the contract shall not be raised.

THE HUNTING PROTOCOL

- 1. The grounds for a financial settlement of the hunt shall be the hunt protocol.
- 2. The protocol, drawn up on a proper form, shall be numbered and shall specify the type and number of the game shot, the sizes of trophies, the date of stay.
- 3. The protocol shall be drawn up after the hunt and the trophies evaluation, in the presence of the client, by a committee composed of one representative of the Local Hunting Club and one of travel agency, in the English language or a language familiar to the client.
- 4. The protocol shall be the grounds pursuant to which the trophies may be taken out of determined country.
- 5. Trophies evaluation shall be conducted generally 24 hours after they have been prepared. The trophies' weight specified during the evaluation shall constitute the grounds for payment for the trophies and shall not be subject to complaint.
- 6. Apart from the trophies, the client shall have the option, for additional payment and with consent from the local Hunting Club, to take out from determined country the skin or meat of the game shot, on the condition that this fact has been recorded in the hunting protocol.
- 7. The client in the protocol shall make any and all remarks and observations concerning the hunt before it has been signed.

RESIGNATION FROM THE HUNTING TRIP

- 1. Resignation from the hunting trip may only be in writing. The resignation date shall be held to mean the date of the reception of the resignation by *Arms & Ammo Solutions, s. r. o.*
- 2. If *Arms & Ammo Solutions, s. r. o.*, changes, in a significant manner, the conditions of the contract, the client shall be entitled to dissolve the contract without incurring further costs. In such a case, when is *Arms & Ammo Solutions, s. r. o.*, forced to cancel a



hunting trip, because the client's fundamentally conduct undermine the orders of hunting trip, has the **Arms & Ammo Solutions**, s. r. o., entitled to a full refund of the amount already paid by client / DEPOSIT.

- 3. In the event of resigning from the hunting trip the costs charged upon the client shall be the following:
 - ✓ a handling fee of € 20 per person in the case of resigning 30 days prior to the starting date of the trip,
 - ✓ 25% of the trip's costs in the case of resigning 29-21 days prior to the starting date of the trip,
 - ✓ 50% of the trip's costs in the case of resigning 20-14 days prior to the starting date of the trip,
 - ✓ 75% of the trip's costs in the case of resigning 13-7 days prior to the starting date of the trip,
 - ✓ 100% of the trip's costs in the case of resigning 6-0 days prior to the starting date of the trip.

The trip's costs shall be held to mean here the costs of stay during the hunting trip according to **Arms & Ammo Solutions**, s. r. o., current price list.

4. The client shall not be charged with any costs due to withdrawing from the contract if he proposes another person that shall meet the participation requirements and upon whom he shall transfer his rights and who shall take over the responsibilities arising there from.

PERFORMANCE OF CONTRACT AND COMPLAINTS

- 1. **Arms & Ammo Solutions, s. r. o.,** is liable to the client for thorough preparation of the hunting trip and thorough performance of duties arising from the contact.
- 2. In exceptional cases *Arms & Ammo Solutions, s. r. o.*, reserves itself the possibility and right to change the hunting ground and the lodgings into equal standard lodgings, or in the event of lack of such, into lower standard lodgings with simultaneous refund of the price discrepancy. However, if *Arms & Ammo Solutions, s. r. o.*, changes the lodgings into ones of a standard higher than specified in the contract, the client shall not be charged any further costs in respect of this.
- 3. Arms & Ammo Solutions, s. r. o., shall not be liable for shortcomings of the hunting trip arising from reasons beyond its control (e.g. atmospheric conditions, decisions of the State Authorities, force majeure) as well as shortcomings caused by the participants. Entitled to a refund of DEPOSIT as a result of unsuccessful hunting does not arise also, if the participant had the opportunity to hunt and shooting opportunity to take action, in accordance with the order of the selected type of game, but he refused to enforce, or if the client repeatedly frustrate the hunt.
- 4. Arms & Ammo Solutions, s. r. o., shall not be liable for losses arising from public transport delays, public transport timetable amendments, loss of luggage, money, precious belongings, arms, or for accidents, as well as for any other causes beyond the control of Arms & Ammo Solutions, s. r. o.
- 5. Arms & Ammo Solutions, s. r. o., shall not be liable for changes to the hunting trips program arising from the clients late arriving.
- 6. During foreign hunters' stay at a hunt in determined country, the provisions of the Hunting Law of determined country apply. A representative of the local Hunting Club shall present these provisions to the hunters in a language familiar to them, prior to the commencement of the hunt.
- 7. In the event of violation of the law, particularly of violation of hunting safety regulations, the organizer of the hunt (the Hunting Club) shall have the right to exclude a hunter from the hunt, or even, in the case of a driven hunt, to cancel the hunt. In such cases **Arms & Ammo Solutions**, s. r. o., shall not be liable in any fashion for the organizer's decisions and shall not pay damages in respect of this.
- 8. The client shall be obliged to make amends for the damage caused by himself or by any persons in his custody.
- 9. The grounds for considering a complaint shall be:
 - ✓ the fact of reporting to the tour guide immediately after the subject of complaint occurs so that it can be eliminated as soon as possible.
 - ✓ if the subject of complaint has not been eliminated, it shall be required that remarks in writing should be made in the hunt protocol,
 - ✓ any and all complaints shall be filed in writing within 7 days since the hunting trip's finishing date,
 - ✓ Arms & Ammo Solutions, s. r. o., shall be obliged to consider a complaint within 30 days and to reply in writing.

FINAL PROVISIONS

1. In matters not regulated herein relevant provisions of the Slovak Civil Code and Act on business conditions tour operators and travel agencies 281/2001 apply.
